The purpose of the Maintenance Management Order (MMO) is to inform the MPFSM 1000 sites of the Planet code Retrofit Plan. The sites are directed to ensure that the FSM1000 machines and the FMBCRs are in good running condition, with mechanical reject rate below 3%. It is imperative that the sites resolve all the technical problems related to the FMBCR camera. The sites must also run bar coded mail on the machine to establish a baseline read rate one week prior to Lockheed Martin Federal System (LMFS) installation team's arrival.

The Attachment 1 contains the Planet Code Retrofit Plan. The Attachment 2 is the Deployment Schedule (for reference only and is subject to minor changes), please contact your In Plant Support office for further deployment information.

ATTACHMENT 1**PLANET CODE RETROFIT PLAN****1 INTRODUCTION**

Lockheed Martin Federal Systems (LMFS) is providing this plan to Retrofit the Trainers (4), Eng. Simulators (2), Stand alone at Norman (2), Lake Mary (1) and serial numbers 1 - 351.

CONFIRM is a new product line from the United States Postal Service that uses a special bar code called PLANET to track mail pieces electronically. The PLANET code design is similar to the existing POSTNET code and requires a relatively simple modification to read the new PLANET codes. Implementation of PLANET codes will be the basis of new revenue and information gathering for the Postal Service. Thus, the USPS has adopted the usage of PLANET codes in order to implement them for flat mail on existing Flat Bar Code Reader (FMBCR) units currently deployed throughout the United States on FSM1000 mail sorting equipment. Implementation of PLANET code capability requires software / firmware and hardware modifications which will enable the FSM1000 to successfully detect, read, and process different types of PLANET codes without degrading the previously-established FMBCR read rate.

2 GENERAL TASK DESCRIPTION

This task will be performed by 7 teams consisting of 1 experienced installer from Lockheed Martin Federal Systems (LMFS). Each Team member has a set of locations to upgrade. They will fly to the first installation sight and rent a suitable car to carry their own personal tools and luggage. They will perform the activities per the site plan and will proceed directly to the next site per schedule. Provisions have been made to the car kit for any foreseeable problem that might occur at the site; i.e., spare UART chips, one complete set of PROMS for upgrade of boards. They are there to perform only the activities scheduled. They will leave the machine in the same condition that it was in when they started. This will be verified by the end of run report. They will then proceed to the next site on the schedule. Provisions have been made to have a "hot spare" team available out of LFMS to help any team that is behind Schedule. IT IS IMPERITIVE THAT WE STAY ON SCHEDULE.

3 SCHEDULE

Following this discussion is the schedule sorted by date. The following assumptions/conditions were considered when creating this plan:

The Start of the program is 7/05/00.

The system will be available for the starting at 8:30 A.M.

The duration of the retrofit effort will be 1.25 days, Monday - Friday.

The teams are flexible to site machine access times as per need basis.

Schedule adjustments were made for Independence Day, and September 1st, Labor Day.

4 NOTIFICATION PLAN

There are three activities planned to notify the sites when the FSM1000 machine will be needed for the retrofit.

4.1 ANNOUNCEMENT

LMFS customer assistance center will contact each site coordinator on or about 3 weeks prior to the teams' arrival, in order to inform the designated site of the upgrade and to check on the status of the machine (s). Each postal site has the responsibility to have each FSM1000 (FMBCR included) Machine completely / fully operational including proper alignment, calibrate, and test deck / mail run verification prior to LMFS team member arriving for the designated site's upgrade.

4.2 1 WEEK PRIOR NOTIFICATION

On or about 1 week prior to the team arriving the LMFS team leader will call the site coordinator and the Site Maintenance Manager to remind them that the LMFS team will be there. In addition, the LMFS team leader will verify that each machine is completely / fully operational prior to his arrival.

4.3 2 DAYS PRIOR TO THE RETROFIT

The team leader will call from the current Postal Facility, where the retrofit is being performed, to inform the next site of their arrival time.

5 ACTIVITIES TO BE PERFORMED

5.1 UPGRADE ACTIVITIES

- Remove and Replace four PROMS in each FMBCR's machine Master, Slave and POSTNET PCB'S (3)
- Remove and Replace four PROMS in FMBCR site spares Master, Slave and POSTNET PCB'S in stock at site.
- Remove and Replace one UART chip in each machine on I/O 7260C Boards (10).
- Remove and Replace one UART chip in site spare on I/O 7260C Board.
- Install new software version 6.5.0 and verify its operation.

NOTE

Replacement of site spares will occur only when presented with site asset for pending replacement.
