29 CFR 1910.147(c)(4)(i): Procedures were not developed, documented and utilized for the control of potentially hazardous energy when employees were engaged in activities covered by this section:

- a. Employees were observed to be performing maintenance on Delivery Bar Code Sorter #8 under the LO/TO program. The LO/TO Procedure being used and posted on the machine for use was Procedure #143 for DBCS Input/Output Subsystem (DIOSS) #8. The machine being worked on was changed from a DIOSS to a DBCS in May of 2008 and the LO/TO Procedure was not updated to reflect this change. This condition exposed employees to the hazard of contacting energized electrical circuits and/or struck-by hazards.
- b. Employees were allowed to perform maintenance under the LO/TO program on the Small Parcel and Bundle Machine (SPBM) that became operational in June of 2008 and no local LO/TO procedure had been developed. A factory procedure was posted on the machine that had an area left blank for the local user of the machine to insert the location where the machine could be disconnected from the source of electrical power for the machine. This area was not filled in (it was blank). This condition exposed employees to the hazard of contacting energized electrical circuits and/or struck-by hazards.
- c. Employees were allowed to perform maintenance under the LO/TO program on the Loose Mail Sorter (LMS) that became operational in June of 2008 and no LO/TO procedure had been developed. This condition exposed employees to the hazard of contacting energized electrical circuits and/or struck-by hazards.

29 CFR 1910.335(a)(1)(i): Employees working in areas where there were potential electrical hazards were not provided with, and/or did not use, electrical protective equipment that was appropriate for the specific parts of the body to be protected and for the work to be performed:

Employees were allowed to perform troubleshooting operations on energized electrical equipment in the direct vicinity of hazardous voltages: to include but not limited to 480, 277 and 208 volts without personal protective equipment. This condition exposed the employees to the hazards of arc-blast, arc-flash and contacting energized electrical circuits.
