Dear Judge Sommer:

Enclosed please find the Motion of the Complainant for Consolidation of Cases and Stay, and proposed Order Granting Consolidation and Stay of Proceedings.

As you will note from the motion there are numerous citations that have issued, and are about to issue, against the U.S. Postal Service nationwide for similar violations of electrical safety work practices, 29 C.F.R. §§1910.331-335. Complaints have been filed in at least five (5) cases to date. Nine (9) other cases are pending before the Commission and three (3) citations have issued with contests expected. See Attachment A to motion. The inspections continue with more citations expected. Given the common issues and parties, and the number of citations to be issued in total, which may exceed 30-40, a consolidation of all these cases would conserve judicial and litigation resources.

Additionally, a stay of at least 90 days is being sought while the parties attempt to negotiate a settlement. Negotiations involving the Secretary, the U.S. Postal Service, and the American Postal Workers Union, AFL-CIO have already been initiated.

MOTION OF THE COMPLAINANT FOR CONSOLIDATION OF CASES AND STAY

The Complainant hereby moves pursuant to Procedural Rule §2200.9 of the Occupational Safety and Health Review Commission that the above captioned matter be consolidated with other related pending cases before the Commission, and be considered a continuing motion for anticipated future cases to be soon filed, based on citations either already issued or to be issued against the Respondent throughout the country for alleged violations of electrical safety related work practices, 29 C.F.R. §1910.331-335, by the Respondent in its Processing and Distribution Centers and National Distribution Centers. The Respondent has approximately 260 such facilities across the country with common or similar electrical safety issues. Thus, the Secretary's complaint filed with the Commission in this matter on July 6, 2010 seeks enterprise-wide relief under the Commission's grant of authority to issue an order "directing other appropriate relief."

In support of the motion for consolidation, the Complainant asserts that the above matter was the first of numerous inspections initiated by the Complainant beginning in October 2009 across the country. Since that time at least five complaints and a significant number of citations arising from comparable conditions have issued. (See Attachment A). It is anticipated that all of these citations will be contested and, therefore, will eventually be on the Commission's docket. Additional citations are continuing to issue in the interim.

The parties are in the process of initiating settlement negotiations intended to resolve all these matters. Given the scope of the Secretary's investigations of the Respondent, including the significant number of citations already issued with respect to the electrical violations, those anticipated to be issued, and the cases currently pending before the Commission assigned to various judges, consolidation of all matters involving the Complainant and Respondent concerning violations of the electrical standards will conserve judicial and litigation resources, and is in the best interests of the Commission and the parties.

Similarly, the Complainant further moves pursuant to Rule § 2200.63 that there be a short stay of proceedings to allow the parties to pursue their negotiations at the national level and not be hampered in the interim by discovery issues or even mandatory settlement proceedings. Discussions between the parties have already initiated and, given the scope and nature of the matter, a settlement would appear to have reasonable prospects.

Accordingly, the Complainant requests a consolidation of all existing matters set forth in Attachment A, and future cases that come before the Commission as will be specifically identified by the parties that pertain to violations under 29 C.F.R. §1910.331-335, once the cases enter the Commission's docket. Complainant further requests that the proceedings for all these cases be stayed in the interim for at least 90 days pending on-going negotiations (except for the filing of complaints).

Both the Respondent and the American Postal Workers Union, AFL-CIO have been advised of this motion. The undersigned has conferred several times with both parties but each party has a separate position on the scope and length for the stay of proceedings and it is best for each party to present its own position to the court.

The Complainant has moved pursuant to Procedural Rule § 2200.9 of the Occupational Safety and Health Review Commission to have the above cited matter consolidated (1) with other related pending cases before the Commission and (2) with anticipated future cases to be soon filed, based on citations either already issued or to be issued against the Respondent throughout the country for alleged violations of electrical safety related work practices, 29 C.F.R. §§1910.331-335 in its Processing and Distribution Centers and National Distribution Centers. Having reviewed the motion, I find that there are common issues and that consolidation would be in the interests of judicial economy.
