


THE COLA INCREASE IS A GREAT CHANCE TO BUILD OUR UNION

Career postal workers under the main APWU/USPS contract will see a \$0.48 increase in paychecks dated September 15, 2023. That increase equals \$38.40 per pay period or \$998 annually for a full-time worker. The hourly rates for part-time employees will be adjusted accordingly. The COLAs are in addition to general wage and step increases.

Now is a good time to remind our non-members of what we can achieve by standing together, and how much stronger we would be if we all stood together.

Having a full COLA is a big deal that benefits us all, and maintaining it is no small feat. Our COLA comes from our union-negotiated contract, but the contract is only as strong as our membership. Next year (2024), the APWU will be in negotiations for a new Collective Bargaining Agreement.

SOCIAL SECURITY FAIRNESS ACT

CALL CONGRESS DAY OF ACTION SEPTEMBER 27, 2023

We are calling on every APWU member to participate in our Sept. 27 Call Congress Day of Action and advocate for the passage of the Social Security Fairness Act (H.R. 82 and S. 597).

As an active postal employee, this bill likely does not affect you directly. However, we have learned that fighting together is the path to winning issues that affect us all. APWU retirees have fought tirelessly for active employees, both via legislative and collective bargaining. It is our turn to fight for the benefits they have earned and are being denied!

If passed and signed into law, this legislation would correct a serious injustice that affects many postal and federal retirees by repealing the Government Pension Offset (GPO) and Windfall Elimination Provision (WEP).

In 1984, Congress reduced the Social Security benefits of Civil Service employees under the “guise” that most federal or postal retiree under the Civil Service Retirement System (CSRS) should also have full Social Security benefits, even when they earned them under Social Security regulations.

The WEP invoked a penalty of up to 50 percent of earned Social Security benefits. The GPO applies

to spouses and survivors of a CSRS employee, with the penalty totaling up to a two-thirds loss of earned Social Security.

The bill, introduced by Senator Sherrod Brown (D-OH) and Representative Garret Graves (R-LA-06), has large bipartisan support. As members of Congress return from their August recess, H.R. 82 has obtained 289 cosponsors in the House. We are working with a broad coalition to increase that number and ensure the bill has enough support in both the House and Senate to make it all the way to the president’s desk for signature during this Congress.

To move this issue forward, we are holding a Call Congress Day of Action on Sept. 27.
