This is in further reference to the ongoing correspondences on the establishment of Sorting and Delivery Centers (S&DCs). The purpose of establishing S&DCs is to reduce transportation and mail handling costs as well as provide postal customers with additional services. S&DCs will allow for easier standardization and management of operations will have improved building and operating conditions for employees.

This notice provides updated information regarding sites previously scheduled for conversion to S&DCs with a planned launch date of June 13, 2026 (enclosed), as well as the addition of new S&DCs for which launch timelines are to be determined.
